A roll call vote was taken:

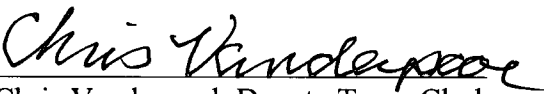

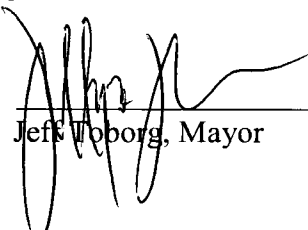
