Secretary: no updates

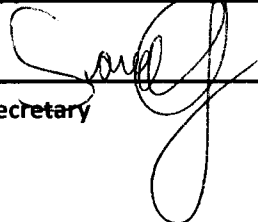
Treasurer and Vice Chair were not present, so no updates from them
