MINUTES

1) Welcome/Roll Call

- The meeting was called to order by Christine at 5:30 pm
- In attendance: Christine Kennedy, Dave Reiter, Mark Steinhäuser, Michael Montoya, Diana Norton-Stucky, Cindie Perry, Hima Mangipudi, and Carrie Glassburn (Staff)
- Absent: None

2) Approval of Minutes From June's PAC Meeting

Cindie made the motion to approve the June minutes, Michael seconded, the motion passed unanimously

3) Budget Review

- Carrie reviewed the current budget with the PAC group.
- We are on track to spend all but about \$500 of our budget by the end of 2025
- Carrie discussed the Long-Range Plan for the Town and the proposal to cease funding the Public Art Reserve Account in 2030.

4) Project Updates

- Fieldhouse Climbing Wall Mural ○ The mural was completed the week of August 4th by Chase Trout and 7 students from American Academy. Images of the final mural were shared.
- Construction Fencing ○ The final design was shared with the group. The new fencing art will be installed on August 20th.
- Parking Garage Mural ○ The concepts of the 4 finalists were shared with the group, and we discussed revisions being made by the winning artist, an idea of the rough schedule for installation, and plans for future public engagement and education.
- Utility Wraps for 2025 ○ Carrie shared the status of the Call for Artist for the 2 public pieces. The Call will hopefully be released early in the week of August 18th with public concepts due by September 15th.
 - Michael agreed to send the Call out to art teachers at area schools
 - Mark and Dave agreed to send the Call to the PAG, the Castle Rock Artists guilds, and other art communities

- Cindie will contact media and other chambers of commerce.
 - Parker Arts will do social media, email blasts, Talk of the Town
 - The group discussed who will be reviewing the submitted concepts and choosing a winner. Diana, Cindie, Christine, and Hima agreed to be on this review panel.
- Plaque Locations for 2025
 - Christine and Dave gave an update on the plaques planned for 2025
 - Parking garage mural plaque will go in next year, might need to be bigger than the typical plaques.
 - Should have current locations and information to Carrie by end of this month.
- Art in the Park
 - Cindie, Hima, Christine have volunteered and Lindsay will contact them.
- Public Works
 - RideShare painting will be another project we take on for the Town
- Mango Mural
 - The Public Art Commission, P3 (urban renewal), and Tony Mango have agreed to partner on this project
 - Graham Carraway has been chosen as the artist to work on the mural
 - Carrie is currently working on contracts for our first private/public partnership
 - Timing for installation TBD

5) Other Business

- Carrie shared the newly adopted Commissioners Manual with the PAC. – Carrie will email it.
- Mark's Term Ends 12/31/2025. He will need to let Carrie know by 10/1/2025 if he is interested in renewing his term.
- Strategic Plan Update – Carrie updated the group that the Town is still working with Keen on this project. We are currently receiving facts and findings, and we'll start reviewing their recommendations next. The plan is due to be wrapped up by the end of the year.
- Future Projects – will be discussed at a later meeting
- October Presentation to Town Council – Carrie gave the group a heads-up that the PAC members will be asked to give an update to Town Council during a Study Session meeting sometime in October. We will discuss the topics to be discussed at our next PAC meeting.
- Christine requested PAC nametags (like the PCSC nametags).
