- 1) Meeting was called to order at 5:34PM
- 2) Welcome/Roll Call
 - Present: Christine Kennedy, Dave Reiter, Mark Steinhauser, Cindie Perry, Diana Norton-Stucky, Hima Mangipudi, Carrie Glassburn (staff)
 - Absent: Michael Montoya (Excused)
- 3) Approval of Minutes from June's PAC Meeting
 - Cindie moves, Dave seconds, unanimous approval
- 4) Budget Discussion
 - Keifer's Crossing Mural
 - Girl Scout started this week.
 - Encourage people to stop by and say hi to Alice the artist.
 - Newlin Gulch Bridge Mural
 - The group reviewed the artists who submitted work for the PACE Parking Garage and narrowed down several possible artists: Noah Baker, Drew Button, Anna Charney, Rachel Dinda, Sandra Fettingis.
 - Christine, Cindie, Mark, and Dave – Committee to select their top 5 to only invite top 3, want them to have bid by mid-August, so this selection needs to happen soon.
 - Carrie, Cindie and Christine will finalize the RFP and send out to top three artists, requesting design proposals.
 - Salisbury Park Wraps
 - CORE has paused its wrap program until further notice, so we will not be proceeding with wrapping the three boxes as planned
 - Salisbury Park Sculpture Dedication Event
 - Timing for this will most likely be this fall. We will coordinate the event with the PROS Team and the grand opening of Phase I of the park.

- Town Hall Exterior Sculpture (Reserve Account)
 - o Kendall and Carrie are working with the selection panel to determine what we are looking for, then they will put out an RFQ to begin the process of narrowing down artists to propose designs for the project.
- PACE Parking Garage Wraps
 - o This project is on hold for now, due to CORE's direction to pause program.
- PACE Parking Garage Website
 - o The PCSC History Committee researched and wrote initial copy. Diana further refined the storyline, and our contractor with Interpret Site assisted with fact checking. Our next step is to work with 1st Tribal Consulting for input on the Native American story. Once all copy is finalized, we will begin to build out the website.
- Fundraising/Sponsorship Role: Discussion deferred to next meeting. The subcommittee will be meeting in July.
- Plaques:
 - o 10 new plaques are being installed this year on existing murals.
 - o We'll need to add a plaque for Spiral Vortex and for the new murals in 2027.

5) New ArtWalk Map Option

- o We are looking at potentially using the Town's GIS system instead of Otocast, to bring the ArtWalk map back into our hands and allow for more citizen interaction.

6) Art in the Park – Need PAC Commissioners to Volunteer (August 29th and 30th)

- o Contact Syd for signing up at Art in the Park. PAC Commissioners should be volunteering because it's an art event.

7) SCFD Reauthorization Roadshow

- August 3rd and 4th (register at scfd.org/reauthorization)
- SCFD grant comes up for reauthorization in 2028, commissioners will need to help us get the word out (but as private citizens, not commissioners). Would be great if you could arrange to attend one of the online sessions above to learn more about SCFD, what it does, what a reauthorization campaign might look like.
